## UPDATE ON ROTARY INTERNATIONAL'S FIVE-YEAR FINANCIAL FORECAST

Hello Fellow Rotarians,

My name is Otha Ray Stearman, PDG, and I would like to thank you for the opportunity to serve as Rotary Zones 30-31, Inc.'s Treasurer for FY2021-FY2023. It is my duty under Rotary's bylaws to provide you with the Update on Rotary International's Five-Year Financial Forecast report on our organization's finances. I have attached a twelve-minute video with Rotary's Chief Financial officer and with the RI Treasurer.

The video includes financial results and updated forecasts through FY2027. Please take a few minutes to watch the video before you arrive in Chattanooga for the *Pathways to the Future 2.0* Institute. I am presenting you the video but also a short synopsis of the major items.

Stewardship of Rotary's assets is a key responsibility of staff and volunteers. Money must be used for its' intended purpose. **Rotarians Trust Rotary!** 

## > Five Year Forecast Assumptions FY23-FY27

- ✓ Revenues (Rotary has 3 major sources)
  - 1. Membership Dues 70%
  - 2. Services & other Activities 28%
  - 3. Investment Return 2%
- ✓ Membership Largest Source of Revenue. Two Main Factors:
  - Number of Members 1.168 million with 37,000 clubs and 221 countries
    - Connect Global Membership Module
    - Partnership with Toastmasters
    - People in Action Campaign
  - Dues Rate Per Member
    - \$4 increase in 2024
    - \$3.50 increase in 2025
    - \$3.50 increase in 2026 Dues pay for:
      - Rotarian Support 57%
      - Administration and Compliance 22%
      - Enhance Image 21%
- ✓ Projected to have sufficient finds to meet the Board Target through 2027

- ✓ Membership projection drops from 1.206 M to 1.168 M and stabilizes
- ✓ Reserves are not a luxury; we must have sufficient funds for unplanned events
- ✓ Rotary by-laws require all budgets to be balanced.
- ✓ The 2016 and 2019 Councils funded to build and upgrade global infrastructure The Learning Center offers over 1600 courses in 24 Languages

- ✓ Improve upon user-friendliness
